### Update on 2016 refinery performance and ongoing projects

At the last meeting of the Detroit refinery's Community Advisory Panel (CAP), Refinery Manager Dave Roland provided the ject is scheduled to be complete in fall of 2018. attendees an update on performance and major projects at the refinery. The refinery finished 2016 with only four designated environmental incidents, which is the second-best year on record.

"And one of those four incidents actually took place in 2015, but we didn't have all the details until 2016," Roland noted. "What we discovered is that one of our emissions tests failed because of sanding grit that was still inside one of our stacks, and although we took care of it, we still paid a fine to the state, which means we classify it as a designated environmental incident."


In terms of safety, the refinery finished the year with 11 injuries. Ten of the injuries resulted in no lost work time. "That number is still much too high, in our view, so personal safety and addressing hazards will be our top focus this year," Roland said.

One of the refinery's biggest projects is the upgrade that will allow it to manufacture lower-sulfur fuels that are required by law. Detailed engineering for that project is more than 80 percent complete and it is on schedule. One of the most important components of the project, currently being manufactured in Italy, will be shipped to the refinery in June. The pro-

The flare in the refinery's West Plant—located at Schaffer and Dix—will be eliminated during fall of 2018, and construction for the project that will allow for its removal began in March.

The project to move the refinery's liquefied petroleum gas (LPG) storage and loading is scheduled to be complete in the

fourth quarter of this year. All eight LPG tanks have been put in place, and a new loading rack is being built for trucks.

#### **Police patrols**

Rich Robell, the refinery's head of security, provided a summary of its jointventure program with the Detroit Police Department to increase the number of patrols in the neighborhood adjacent to the refinery — a program that has been in place since mid-2013. Throughout that time, the project has funded XXXX patrol shifts. The response time for police calls to the neighborhood has averaged about 6½ minutes, which is faster than the response time for the rest of the precinct.
