ORDINANCE NO. 021-083
DATE OF PASSAGE December 14, 2021

An Ordinance Amending "Chapter 25, Article XI, Section 265, Definitions" of the Code of Ordinances.

WHEREAS, the City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under subsection (a) of Section 6 of Article VII of the Illinois Constitution of 1970; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the city code does not currently allow for microblading or microshading within the city;

WHEREAS, the city seeks to amend the code to allow such services;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Aurora, Illinois, as follows: Chapter 25, Article XI, Section 265 is hereby amended as reflected in the attached Exhibit A.

BE IT ORDAINED, that any prior resolutions and ordinances that are inconsistent or conflict with this resolution shall be and hereby be repealed.

1 **Sec 25-265 Definitions**

2 For purposes of this article, the words and terms defined below
3 shall have the following meanings:

4 *Applicant(s)* means any person, firm, company, partnership,
5 corporation or association that applies for a license under this
6 chapter.

7 *Body piercing* means any procedure whereby a part or parts of the
8 human body are pierced by a sharp instrument in order to allow
9 insertion of a piece or pieces of jewelry, a ring(s) or other
10 ornamental device(s) through the orifice(s) thus created.

11 Licensee means any person, firm, company, partnership, corporation
12 or association that owns or operates an establishment where
13 tattooing is performed and any individual who performs or practices
14 the art of tattooing other human beings.

15 Microblade, or microblading is the technique of placing hair like
16 strokes of color under the skin through the use a blade to create
17 the appearance of eyebrow hairs.

18 Microshade, or microshading is the technique of placing hair like
19 dots of color under the skin through the use of a tiny needle to
20 create the appearance of eyebrow hairs.

21 *Tattoo, tattooed or tattooing* means any method of placing designs,
22 letters, scrolls, figures, symbols or any other marks upon or under
23 the skin by the aid of needles or other instruments designed to
24 touch or puncture the skin. Tattoo, tattooed, or tattooing does
25 not include microblading or microshading.
