

RESOLUTION NO. 2025-01

A RESOLUTION AMENDING THE EFFECTIVE DATE FOR UPDATED DRAINAGE UTILITY FEES AS ADOPTED IN RESOLUTION NO. 2024-22

WHEREAS, the City Council recently adopted Resolution No. 2024-22 amending Section 8.030 of the City Fee Schedule regarding updated drainage utility fees effective December 26, 2024; and

WHEREAS, the City Council desires to delay the effective date of the updated drainage utility fees as adopted in Resolution No. 2024-22 from December 26, 2024 to March 26, 2025; and

WHEREAS, the City is authorized by law to charge reasonable fees for the operation and maintenance of the City storm and subsurface drainage utility and facilities with Utah Code Ann. § 10-3-717; and

WHEREAS, the City Council has determined that delaying the effective date of the updated drainage utility fees as adopted in Resolution No. 2024-22 is in the best interest of the City and the businesses and residents to allow additional time to budget and plan for the updated drainage utility fees as more particularly provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CENTERVILLE CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Amendment. The effective date for the updated drainage utility fees adopted in Resolution No. 2024-22 is hereby amended to be delayed from December 26, 2024 to March 26, 2025. All other provisions of Resolution No. 2024-22 not modified by this Resolution shall remain in full force and effect and are hereby ratified and affirmed.

Section 2. Severability Clause. If any section, part, or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.

Section 3. Effective Date. This Resolution shall become effective immediately upon its passage.
