

ORDINANCE NO. 2021-06

AN ORDINANCE AMENDING SECTION 8.02.022 OF THE CENTERVILLE MUNICIPAL CODE TO REFLECT THE NAME CHANGE FOR THE LEE SKABELUND MEMORIAL NATURE PARK

WHEREAS, the City Council has previously enacted Section 8.02.022 of the Centerville Municipal Code listing the current City parks and facilities; and

WHEREAS, the City Council recently renamed the Lee Skabelund Wildland Park the “Lee Skabelund Memorial Nature Park” and desires to also update Section 8.02.022 regarding reference to this park as more particularly provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CENTERVILLE CITY, STATE OF UTAH:

Section 1. **Amendment.** Section 8.02.022 of the Centerville Municipal Code regarding City Parks is hereby amended to read in its entirety as follows:

8.02.022. City Parks.

The following is a list of current City parks. This list may or may not be inclusive and is intended as a courtesy to identify and highlight major City parks. Further information about City Parks and facilities can be found on the City website.

- (a) Community Park – 1350 North 400 West
- (b) Freedom Hills Park – 2150 North 150 East
- (c) Island View Park – 750 East 500 South
- (d) Lee Skabelund Memorial Nature ~~Wildland~~ Park – 100 South 700 East
- (e) Porter-Walton Park – 95 South 400 West
- (f) Smoot Park – 1550 North Main
- (g) William R. Smith Park – 300 North 100 East

Section 2. **Severability Clause.** If any section, part, or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all provisions, clauses and words of this Ordinance shall be severable. This Section shall become effective without codification.

Section 3. **Effective Date.** This Ordinance shall become effective immediately upon publication or posting.
