ORDINANCE NO. 2025-13

AN ORDINANCE AMENDING THE CENTERVILLE CITY ZONING MAP BY CHANGING THE ZONING OF APPROXIMATELY 1.04 ACRES OF CERTAIN REAL PROPERTY LOCATED AT APPROXIMATELY 522 WEST 400 SOUTH (PORTER LANE) FROM RESIDENTIAL-MEDIUM (R-M) TO RESIDENTIAL-MEDIUM WITH A PLANNED DEVELOPMENT OVERLAY (R-M/PDO) AND APPROVING THE CONCEPTUAL PLAN FOR THE PORTER LANE ESTATES PDO

WHEREAS, the City is authorized to enact a zoning map consistent with the purposes set forth in the Utah Land Use Development and Management Act, as more particularly provided in *Utah Code* §§ 10-9a-101, *et seq.*, as amended, and the City is further authorized to make amendments to such zoning map in accordance with procedures set forth in *Utah Code* § 10-9a-503, as amended; and

WHEREAS, in accordance with applicable provisions of Utah law and the goals of the Centerville City General Plan for the subject property regarding development policies for Neighborhood 2, the City Council desires to amend the Centerville City Zoning Map to rezone the subject property from Residential-Medium (R-M) to Residential-Medium with a Planned Development Overlay (R-M/PDO) as more particularly provided herein; and

WHEREAS, as part of the Planned Development Overlay (PDO) Zone requirements, requests for PDO zoning shall include a conceptual site plan for review and acceptance by the City Council concurrent with the rezoning decision; and

WHEREAS, the proposed amendments to the Centerville Zoning Map and Conceptual Site Plan for the Porter Lane Estates PDO as set forth herein have been reviewed by the Planning Commission and the City Council and all appropriate public noticing and hearings have been provided and held in accordance with Utah law to obtain public input regarding the proposed revisions to the Zoning Map and approval of the Conceptual Site Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CENTERVILLE CITY, STATE OF UTAH, AS FOLLOWS:

- Section 1. PDO Rezone and Conceptual Plan Approval. The real property located at approximately 522 West 400 South (Porter Lane) consisting of approximately 1.04 acres as more particularly described in the legal descriptions set forth in Exhibit A, attached and incorporated herein by this reference, is hereby rezoned from Residential-Medium (R-M) to Residential-Medium with a Planned Development Overlay (R-M/PDO) and the Conceptual Site Plan for the Porter Lane Estates PDO, as more particularly described in Exhibit B, attached hereto and incorporated herein by this reference, is hereby approved by the City Council.
- **Section 2.** Findings for PDO Approval. The rezone of the subject property to R-M/PDO and corresponding Conceptual Site Plan approval for the Porter Lane Estates PDO is based on the following findings:
 - (a) The proposed PDO Zoning Map Amendment meets the goals and objectives of the General Plan concerning Neighborhood 2 [CMC 12-480-3].
 - (b) The proposed PDO Zoning Map Amendment meets the use, standards, and applicability in the City Zoning Code 12.32 Residential Zones with the assistance of the PDO allowable variations from applicable land use development standards in the City Zoning Code;

- (c) The proposed PDO Zoning Map Amendment does not conflict with any applicable policy of the General Plan;
- (d) The proposed PDO Zoning Map Amendment meets the purpose and intent of City Codes as set forth in CZC 12.41;
- (e) The proposed PDO Zoning Map Amendment allows for integrated planning and design of the property and, on the whole, better development than would be possible under conventional zoning regulations;
- (f) The proposed PDO Zoning Map Amendment meets the use and development limitations and other requirements of the zone with which the PDO zone is combined, except as otherwise allowed by CZC 12.41;
- (g) The proposed PDO Zoning Map Amendment meets the density limitations and guidance of the General Plan; and
- (h) The proposed Zoning Map Amendment provides superior site design and increased amenities, as required in CZC 12.41.080(c);
- (i) Therefore, the City Council approves the proposed Planned Development Overlay Zoning Map Amendment request as associated with the provided Conceptual Site Plan documentation.
- **Section 3.** <u>Severability</u>. If any section, part, or provision of this Ordinance is held invalid or unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts and provisions of this Ordinance shall be severable.
- **Section 4.** Effective Date. This Ordinance shall become effective upon publication or posting, or thirty (30) days after passage, whichever occurs first.
