## CITY OF FRANKLIN, OHIO ORDINANCE 2023-07

## AMENDING SECTION 1105.09 OF THE CITY OF FRANKLIN CODIFIED ORDINANCES TO UPDATE THE FEE SCHEDULE FOR PLANNING AND ZONING RELATED PROCEDURES

WHEREAS, Section 1115.04 of the City's Unified Development Ordinance (UDO) allows amendments to the text of the UDO to be initiated by Planning Commission, upon its own motion; and

WHEREAS, on February 15, 2023, the Franklin City Planning Commission initiated, upon its own motion, Planning Commission Case 23-05, which would amend UDO Section 1105.09 Fees (the "Amendments"); and

WHEREAS, Planning Commission held a public hearing on the Amendments during its regularly scheduled meeting on March 8, 2023 in accordance with UDO Section 1115.04; and

WHEREAS, following the public hearing, Planning Commission unanimously passed a motion to recommend approval of the Amendments to City Council;

WHEREAS, City Council reviewed the recommended Amendments (attached as "Exhibit A" to this Ordinance), and held a public hearing on the same, during its regularly scheduled meeting on April 3, 2023; and

WHEREAS, City Council finds the Amendments are in the best interests of the City of Franklin and its residents and, therefore, the recommendation from Planning Commission to approve the Amendments is well-taken and shall be adopted by Council pursuant to this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FRANKLIN, WARREN COUNTY, OHIO THAT:

<u>Section 1</u>. Section 1105.09 of the City's Codified Ordinances is hereby amended as set forth in Exhibit A, attached hereto.

Section 2. All ordinances or parts of ordinances that conflict with this Ordinance are hereby repealed.

<u>Section 3</u>. It is found that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action occurred in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.
