**A RESOLUTION AMENDING THE PUBLIC SAFETY FEES IN THE GRANTSVILLE CITY
CONSOLIDATED FEE SCHEDULE**

WHEREAS, this Resolution is for the purpose of amending the public safety fees related to redaction of records for Government Records Access and Management Act (GRAMA) requests, legal discovery requests and body-cam recordings;

WHEREAS, this Resolution is also amending the Quarantine Fee and Daily Maintenance Fee for the Grantsville City Animal Shelter;

WHEREAS, the City Council finds these amendments will promote the health, safety and welfare of the public and is in the best interest of Grantsville City.

NOW THEREFORE, be it ordained by the Council of Grantsville, in the State of Utah, as follows:
