**A RESOLUTION OF THE GRANTSVILLE CITY COUNCIL REVISING FIRE
DEPARTMENT VEHICLE USE FEES**

WHEREAS, Grantsville City is authorized under section 10-3-717(1)(b) of Utah Code to establish fees charged for municipal services, such as fire fighting;

WHEREAS, the Grantsville City Fire Department uses various fire vehicles to provide fire fighting services and incurs expenses to the City for such use;

NOW THEREFORE, be it ordained by the Council of the Grantsville, in the State of Utah, as follows:

SECTION 1: **AMENDMENT** “Public Safety Fees” of the Grantsville Fee Schedule is hereby *amended* as follows:
