

Resolution 2019-07

A RESOLUTION AMENDING THE 2018-2019 OPERATING BUDGET

WHEREAS, Heber City would like to proceed with the slurry seal project prior to 2019-2020 fiscal year; and

WHEREAS, Heber City would like to proceed on the removal of the 100 North and 100 East Roadway Dip; and

WHEREAS, Heber City would like to proceed with a High Visibility Crosswalk & Pedestrian Activated Flashing Beacon System on 1200 South; and

WHEREAS, Expenditures associated with Planning Development Review Fees has come in significantly higher; and

WHEREAS, the Utah State law requires that city budgets be amended by resolution; and

WHEREAS, a public hearing was held on April 16th, 2018, at the City Council's regularly scheduled meeting, complying with State law;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF HEBER CITY, UTAH that pursuant to Utah State Code 10-6-128, the 2018-19 Heber City Budget is hereby amended to appropriate \$500,000 for the Crack Sealing, \$100,000 for the Removal of Dip, \$120,000 for the High Visibility Crosswalk on 1200 South and \$75,000 for the Planning Development Review Fees as set forth below:
