

ORDINANCE NO. 88-06

AN ORDINANCE AMENDING THE HEBER CITY ORDINANCES NO. 199 &  
235 WHICH DEAL WITH ZONING AND REGULATION OF SIGNS

BE IT ORDAINED by the City Council of Heber City, Utah:

1. Section 02.1108 of the Zoning Ordinance No. 199 is hereby amended to read as follows:

02.1108                    ZONING ADMINISTRATOR APPOINTED

"The governing body shall appoint a Zoning Administrator and a Building Inspector, these two positions may be filled by one person, who will be charged with the administration and enforcement of this ordinance. The governing body may also appoint other officers to assist in the administration and enforcement of this ordinance."

2. Section 02.1117 of Ordinance No. 199 is hereby amended to read as follows:

02.1117                    APPLICATION TO APPEAR BEFORE THE  
BOARD OF ADJUSTMENTS

"Any citizen or person, or any officer of a department of the municipality may appeal to the Board of Adjustments by filing a request in writing with the Zoning Administrator and by paying a fee of \$10.00, provided such appeal is made within (45) days from the grant or refusal of a building permit and/or Certificate of Zoning Compliance by the Zoning Administrator. The request to appear before the Board of Adjustments shall be made on forms furnished by the Zoning Administrator at least 15 days prior to the date of the hearing of the appeal."

3. Section 02.1930.22 Ordinance No. 235 is hereby amended as follows:

- a. The title line of Section 02.1930.22 is hereby changed to read:

"SPACING AND SIZE REQUIREMENTS FOR OFF-PREMISE SIGNS"

and

- b. There is added to said Section 02.1930.22 the

following subparagraph:

"(4) Maximum size of off-premise signs is 50 square feet."

4. DATE OF EFFECT:

This ordinance shall take effect and be inforce from and after its adoption and publication.
