

ORDINANCE NO. 2017-21

AN ORDINANCE ADOPTING SECTION 18.68.075 SHIPPING CONTAINERS IN CHAPTER 18.68 SUPPLEMENTARY ZONING REGULATION OF THE HEBER CITY MUNICIPAL CODE.

BE IT ORDAINED by the City Council of Heber City, Utah, Section 18.68.075 of the Heber City Municipal Code is **adopted** to read as follows:

18.68.075 Shipping Containers

- A. Shipping Container shall mean "A large metal box used for the transportation of goods".
- B. The keeping of shipping containers is prohibited in all residential zones.
- C. Exceptions. A shipping container may be located on a residential property when:
  - 1. The container is being used to store personal property in conjunction with a move to or from said property, not to exceed 2 weeks; or
  - 2. The container is being used for the storage of construction equipment with an active building permit.
- D. In no case shall any containers be placed in the public right of way.

This Ordinance shall take effect and be in force from and after (a) its adoption, (b) a copy has been deposited in the office of the City Recorder and (c) a short summary of it has been published in the Wasatch Wave, but not prior to the 15<sup>th</sup> day of June, 2017.
