

HERRIMAN CITY
ORDINANCE NO. 2025-13

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE CITY OF HERRIMAN, UTAH; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

WHEREAS, the Herriman City Council ("Council") met in regular meeting on May 14, 2025 to consider, among other things, approval of the recodification of the Herriman City Ordinances; and

WHEREAS, Utah Code §10-9a-102 grants the Herriman City authority to enact ordinance that the Herriman City Council ("City Council) considers necessary or appropriate; and

WHEREAS, The Herriman City Planning Commission has held a public hearing and reviewed the subject text amendment; and

WHEREAS, The Herriman City Planning Commission recommended approval; and

WHEREAS, Council has reviewed the proposed changes in the recodification of the Herriman Code of Ordinances and hereby find that it is in the best interests of the public to approve the recodification;

NOW, THEREFORE, BE IT ORDAINED By THE CITY COUNCIL OF HERRIMAN CITY

Section 1. The Code entitled "Code of Ordinances of Herriman City, Utah," published by CivicPlus, LLC, consisting of titles 1 through 12, each inclusive, is adopted.

Section 2. All ordinances of a general and permanent nature enacted on or before February 12, 2025, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. Unless another penalty is expressly provided, every person convicted of a violation of any provision of the Code or any ordinance, rule or regulation adopted or issued in pursuance thereof shall be punished by a fine not to exceed the maximum Class B misdemeanor fine under U.C.A. 1953, § 76-3-301. Each act of violation and each day upon which any such violation shall

continue or occur shall constitute a separate offense. The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance. In addition to the penalty prescribed above, the city may pursue other remedies such as abatement of nuisances, injunctive relief and revocation of licenses or permits.


Section 5. Additions or amendments to the Code when passed in such form as to indicate the intention to make the same a part of the Code shall be deemed to be incorporated in the Code, so that reference to the Code includes the additions and amendments.

Section 6. Ordinances adopted after February 12, 2025, that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.

This ordinance assigned no. 2025-13, shall take effect immediately upon passage and acceptance as provided herein.


