**A RESOLUTION AMENDING THE KAYSVILLE CITY CONSOLIDATED FEE
SCHEDULE FOR FISCAL YEAR 2026 RELATED TO MASSAGE
ESTABLISHMENT BUSINESS LICENSE FEES**

WHEREAS, the Kaysville City Council, passed an ordinance related to business licenses for massage establishments; and

WHEREAS, massage establishment business licenses will require more processing than other commercial business licenses; and

WHEREAS, the Kaysville City Council has adopted a FY 26 Consolidated Fee Schedule with fees for business licenses; and

WHEREAS, the Kaysville City Council feels that it is advisable to amend the fees.

NOW THEREFORE, be it ordained by the Council of the Kaysville City, in the State of Utah, as follows:

SECTION 1: **AMENDMENT** “BUSINESS LICENSE FEES” of the Kaysville Consolidated Fee Schedule is hereby *amended* as follows:




