

ORDINANCE NO. 534

ENACTING AS AN ORDINANCE, ADDITIONAL CHAPTERS TO BE INSERTED INTO THE VILLAGE CODE FOR THE VILLAGE OF MACKINAW REVISING, AMENDING, RESTATING, CODIFYING, AND COMPILING CERTAIN EXISTING GENERAL ORDINANCES OF THE VILLAGE DEALING WITH ZONING AND SUBDIVISIONS.

WHEREAS, in Ordinance 513 the present subdivision and zoning ordinances of the Village of Mackinaw are incomplete and inadequate and the manner of arrangement, classification and indexing thereof is insufficient to meet the immediate needs of the Village; and

WHEREAS, the Acts of the State Legislature of the State of Illinois empower and authorize the Village Legislative Body of the Village to revise, amend, restate, codify and to compile any existing ordinance or ordinances and all new ordinances not heretofore adopted or published and to incorporate said ordinances into one ordinance in book form; and

WHEREAS, the Legislative Body of the Village of Mackinaw has authorized a general compilation, revision and codification of the ordinances of the Village of a general and permanent nature and publication of such ordinances in book form.

NOW, THEREFORE, BE IT ORDAINED by the Legislative Body of the Village of Mackinaw that:

Section 1. The subdivision and zoning ordinances of the Village of Mackinaw are herein revised, amended, restated, codified, and compiled in book form are adopted as and shall constitute Chapters 152 and 153 of the "Code of Ordinances of the Village of Mackinaw".

Section 2. All prior zoning and subdivision ordinances shall be deemed repealed from and after the effective date of said Code except as they are included and reordained in whole or in part in said Code; provided such repeal shall not affect any offense committed or penalty incurred or any right established prior to the effective date of said Code, nor shall such repeal affect the provisions of ordinances levying taxes, appropriating money, annexing or detaching territory establishing franchises or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing of money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plat or dedication of land to public use, naming or vacating or setting the boundaries of streets, alleys or other public places, nor to any other ordinance of a temporary or special nature or pertaining to subjects not contained therein.

Section 3. Said Chapters 152 and 153 of the Village Code of the Village of Mackinaw shall be deemed published as of the day of its adoption and approval by the Village Legislative Body and the Clerk of the Village of Mackinaw is hereby authorized and ordered to file a copy of said Code in the Office of the Village Clerk.

Section 4. Said Chapters 152 and 153 of the Village Code of the Village of Mackinaw shall be in full force and effect four weeks from the date of its publication and filing thereof in the Office of the Clerk, and said Code shall be presumptive evidence in all courts and places of the ordinance and all provisions, sections, penalties and regulations therein contained and of the date of passage, and that the same is properly signed, attested, recorded and approved and that any public hearings and notices thereof as required by law have been given.
