BE IT KNOWN AND REMEMBERED THAT, the Magna Metro Township Council met in a regular public meeting on January 3, 2017

WITNESS

WHEREAS, the incorporation of the Magna Metro Township requires the Council to adopt a Land Use Plan and Code of Ordinance for Magna, per State Law; and

WHEREAS, prior to the creation of the Magna Metro Township, Salt Lake County was the governing jurisdiction responsible for writing these plans, rules and regulations for Magna; and

WHEREAS, Salt Lake County also adopted a Magna General Plan to guide land use decisions in Magna; and

WHEREAS, Salt Lake County presented copies of the Magna General Plan, Land Use Plan, and an amended copy of the Code of Ordinances used by Salt Lake County at a Metro Township Council Training on December 3, 2016.


WHEREAS, the Magna voters, in the November 3, 2015 election, voted to incorporate as a Metro Township and to join the Greater Salt Lake Municipal Services District (GSLMSD) as members of the District; and

WHEREAS, accepting and adopting the Land Use Plan, General Plan, and Code of Ordinance provides for a smoother transition and creates the basis moving forward for Magna to modify and change these to better reflect the needs and best wishes of the people of Magna.
