AN ORDINANCE AMENDING PART 15, CHAPTER 7, SECTION 15-702(A) OF THE MOORE MUNICIPAL CODE BY ADDING THE EAST AND WEST SERVICE ROADS OF INTERSTATE 35 AND ESTABLISHING A MAXIMUM SPEED LIMIT OF FORTY (40) MILES PER HOUR FROM SOUTHWEST 19TH STREET TO .20 MILES NORTH OF SOUTHWEST 34TH STREET; PROVIDING FOR REPEALER; AND PROVIDING FOR SEVERABILITY.

Be it ordained by the Council of the City of Moore, Oklahoma that:

SECTION 15-702 SPECIAL SPEED REGULATIONS.

A. Speed limits are hereby established, except in school zones, on state and federal highways in the city as follows, and no person shall drive a motor vehicle at a speed in excess of such limits:
