

**ORDINANCE NO. 779(14)**

**AN ORDINANCE AMENDING PART 15, CHAPTER 7, SECTION 15-702(A) OF THE MOORE MUNICIPAL CODE BY ADDING THE EAST AND WEST SERVICE ROADS OF INTERSTATE 35 AND ESTABLISHING A MAXIMUM SPEED LIMIT OF FORTY (40) MILES PER HOUR FROM SOUTHWEST 19<sup>TH</sup> STREET TO .20 MILES NORTH OF SOUTHWEST 34<sup>TH</sup> STREET; PROVIDING FOR REPEALER; AND PROVIDING FOR SEVERABILITY.**

**Be it ordained by the Council of the City of Moore, Oklahoma that:**

**SECTION 15-702      SPECIAL SPEED REGULATIONS.**

- A. Speed limits are hereby established, except in school zones, on state and federal highways in the city as follows, and no person shall drive a motor vehicle at a speed in excess of such limits:
