

ORDINANCE NO. 858 (17)

AN ORDINANCE AMENDING PART 13, CHAPTER 1, ARTICLE A, SECTION 13-101, SECTION 13-103, AND SECTION 13-111 ADOPTING THE 2015 INTERNATIONAL FIRE CODE AS AMENDED AND MODIFIED BY THE OKLAHOMA UNIFORM BUILDING CODE COMMISSION AND ADOPTING LOCAL AMENDMENTS TO SAID CODE; ADOPTING APPENDICES B, C, AND D OF SAID INTERNATIONAL FIRE CODE; AND REPEALING ANY INCONSISTENT ORDINANCES OF THE CITY OF MOORE, STATE OF OKLAHOMA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOORE, OKLAHOMA THAT PART 13, CHAPTER 1, ARTICLE A, SECTION 13-101, SECTION 13-103, AND SECTION 13-111 ARE HEREBY AMENDED TO READ AS FOLLOWS:

CHAPTER 1 - FIRE PREVENTION CODE

ARTICLE A - FIRE CODES AND REGULATIONS

SECTION 13-101 - ADOPTION *OF THE 2015 INTERNATIONAL FIRE PREVENTION CODE AS AMENDED AND MODIFIED BY THE OKLAHOMA UNIFORM BUILDING CODE COMMISSION PURSUANT TO 59 O.S. § 1000.23.*

- A. There is hereby adopted by the city for the purpose of prescribing regulations governing conditions hazardous to life and property from fire or explosion that a certain code known as the 2006 *2015* International Fire Code, recommended by the International Code Council as amended and modified by the Oklahoma Uniform Building Code Commission pursuant to 59 O.S. § 1000.23, being particularly the latest edition thereof, and the whole thereof, save and except such portions as are hereinafter deleted, modified or amended, of which code not less than one copy has been and is filed in the office of the city clerk. The *International Fire Prevention Code*, as amended, is hereby adopted and incorporated as if set out at length herein, and shall be incorporated and considered as a part of this code.
- B. The following additions, amendments, or deletions are made to the Building Code adopted herein:

Section 101.1	Insert: The City of Moore, Oklahoma
Section 109.3-109.4	Insert: Misdemeanor, five hundred (\$500.00) dollars delete: or by imprisonment not exceeding <u>[10]</u> , or both such fine and imprisonment

Section 111.4	Delete: less than [amount] dollars or insert: more than five hundred (\$500.00) dollars
<u>Section 308.1.4</u>	<u>Delete Exception 2.: Where buildings, balconies and decks are protected by an automatic sprinkler system</u> <u>Delete Exception 3. : LP-gas cooking devices having LP-gas container with a water capacity not greater than 2 ½ pounds [nominal 1 pound (0.45 kg) LP-gas capacity].</u>

SECTION 13-103 - AMENDMENTS TO FIRE CODE. ADOPTION OF SPECIFIED APPENDICES

The following sections are hereby revised as follows:

1.	Section 9-54(a).	Delete. Referred to in Section 16-22(a) of the code adopted by this article;
		Insert: Of districts
2.	Section 9-54(b)	Delete. Referred to in Section 16.61 of code adopted by this article.
		Insert: Of districts
3.	Section 9-58(a)	Delete. Referred to in Section 21.6(a) of the code adopted by this article;
		Insert: Of districts
4.	Section 9-59	Change: The limits referred to Section F-2601.2 of the code adopted by this article;
5.	Section 9-60	Change: Fire lanes as referred to in Section F-313.0 of the code adopted by this article must be provided in all shopping centers, industrial, R-3 multi-housing area and other locations as require by the chief of the fire department or his designee. Fire lanes shall be clearly marked and kept open at all times and comply to the requirements of this chapter.

The following appendices to the 2015 International Fire Code are adopted and incorporated by reference and made a part hereof as if fully set forth herein: Appendix B, Appendix C, and Appendix D.

SECTION 13-111 - LIFE SAFETY CODE ADOPTED.


There is hereby adopted for the purposes of establishing rules and regulations for the protection of the public safety from the hazards of fire, smoke, fumes, etc., that certain code known as the 2015 National Fire Protection Association Life Safety Code NFPA 101, ~~being particularly the latest edition,~~ adopted by the State of Oklahoma, thereof and the whole thereof, save and except such portions thereof as are hereinafter deleted, modified, or amended. Not less than one copy has been and now is filed in the office of the city clerk. The code is hereby adopted and incorporated as fully as if set out at length herein. (Ord. No. 515(90), 9/17/90)

Severability: If any of the provisions of this ordinance are determined to be unconstitutional or unlawful by any court of competent jurisdiction, the remainder shall be several and unaffected.


Repealer: Any ordinance or parts thereof in conflict with this section are hereby repealed.
