AN ORDINANCE AMENDING PART 5, CHAPTER 9, SECTIONS 5-901 THROUGH 5-902, ADOPTING THE 2015 INTERNATIONAL FUEL GAS CODE AS AMENDED AND MODIFIED BY THE OKLAHOMA UNIFORM BUILDING CODE COMMISSION AND ADOPTING LOCAL AMENDMENTS TO SAID CODE; AND REPEALING ANY INCONSISTENT ORDINANCES OF THE CITY OF MOORE, STATE OF OKLAHOMA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOORE, OKLAHOMA THAT PART 5, CHAPTER 9, SECTIONS 5-901 THROUGH 5-902 ARE HEREBY AMENDED TO READ AS FOLLOWS:

SECTION 5-901- INTERNATIONAL FUEL GAS CODE 2006 ADOPTED ADOPTION OF THE 2015 INTERNATIONAL FUEL GAS CODE AS ADOPTED BY THE OKLAHOMA UNIFORM BUILDING CODE COMMISSION PURSUANT TO 59 O.S. §1000.23.

Pursuant to section 2-15, Moore City Charter, the council may by ordinance adopt, by reference, codes which shall be considered to have the same effect as if set out in full in the City Code. Pursuant to this authority the council hereby ordains that a certain document, at least one copy of which is on file in the office of the city clerk of the city, being marked and designated as "The 2015 International Fuel Gas Code 2006" as published by the International Code Council, as adopted by the Oklahoma Uniform Building Code Commission pursuant to 59 O.S. §1000.23 is hereby adopted as the Fuel Gas Code of the City; for addressing the design and installation of fuel gas systems and gas-fired appliances as herein provided. Each and all of the regulations, provisions, penalties, conditions and terms of the International Fuel Gas Code as hereby referred to, adopted and made a part hereof, as if fully set out in this chapter, with the additions, insertions, and changes, if any, as prescribed and set out herein.

SECTION 5-902- ADDITIONS, INSERTIONS AND CHANGES

The following section(s) of "The International Fuel Gas Code-2006-2015" are hereby revised, deleted, or amended as set out below. Items in [] are phrases that shall be deemed inserted into the appropriate section of the International Code:

1. Section 108.4 Insert: [Violation]

[Two Hundred Dollars (\$200.00)]

Delete: or by imprisonment not exceeding [Number of Days], or both such fine and imprisonment.

2. Section 101.1 Title: These regulations shall be known as the Fuel Gas Code of the City of Moore, Oklahoma, hereinafter referred to as "this code".

Severability: If any of the provisions of this ordinance are determined to be unconstitutional or unlawful by any court of competent jurisdiction, the remainder shall be several and unaffected.

Repealer: Any ordinance or parts thereof in conflict with this section are hereby repealed.
