## CITY OF MOORE ORDINANCE 986 (21)

## AN ORDINANCE AMENDING PART 7, CHAPTER 2, SECTION 7-205, MOORE MUNICIPAL CODE (2018) ADDING NEW LETTER K, PROVIDING AN EXCEPTION TO COMPETITIVE BIDDING AND AUTHORIZING PURCHASE OF SUPPLIES, MATERIALS AND EQUIPMENT FROM BIDDING COOPERATIVES; PROVIDING FOR REPEALER; PROVDING FOR SEVERABILITY.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MOORE, IN THE STATE OF OKLAHOMA, AS FOLLOWS:

**SECTION 1:** <u>AMENDMENT</u> "Sec 7-205 When Bidding Not Required" of the Moore Municipal Code is hereby *amended* as follows:

## AMENDMENT

Sec 7-205 When Bidding Not Required

The following may be purchased without giving an opportunity for competitive bidding:

- A. Supplies, materials, equipment or contractual services where cost does not exceed \$50,000.00 in a single transaction;
- B. Supplies, materials, equipment or contractual services which can be furnished only by a single dealer, or which have a uniform price wherever bought;
- C. Supplies, materials, equipment or contractual services purchased from another unit of government at a price deemed below that obtainable from private dealers, including war surplus, or purchased at auction at a price deemed below that obtainable elsewhere;
- D. Equipment to replace existing equipment which has become inoperable when the council declares the purchase an emergency;
- E. Contractual services (gas, electricity, telephone service, and the like) purchased from a public utility at a price or rate determined by the state corporation commission or other government authority;
- F. Supplies, materials, equipment or contractual services when purchased at a price not exceeding a price set therefor by the state purchasing agency, the Federal Purchasing Agency known as the United States General Services Administration (GSA), or any other state or federal agency authorized to regulate prices for things purchased by the state or United States (whether such price is determined by a contract negotiated with a vendor or otherwise); Department of Corrections (DOC) products;
- G. Contractual services of a professional nature, such as engineering, architectural, medical and legal services;
- H. Supplies, materials or equipment purchased from a vendor or another state governmental entity, at a price not exceeding a price established under the competitive

bidding process undertaken by the governmental entity, such as a county or city government, provided that the competitive bid was a valid competitive bid, was submitted to more than three vendors, and no more than six months have passed since the receipt of the bids or proposals by the governmental entity. Proof of the above shall be presented to council with any request for an exception under this section;

- I. Public construction contracts not exceeding the amount established by state law, awarded by the city for the purpose of making any public improvements or constructing any public building or making repairs to or performing maintenance on the same. Public improvement as used in the previous sentence shall mean any beneficial or valuable change or addition, betterment, enhancement or amelioration of or upon any real property, or interest therein, belonging to a public agency, intended to enhance its value, beauty or utility or to adapt it to new or further purposes. The term "public improvement" does not include the direct purchase of materials, equipment or supplies by a public agency or any personal property as defined in 62 O.S. § 430.1(B); or
- J. Material or equipment needing repair when covered by a policy of insurance where the repair does not exceed \$15,000.00.
- K. Supplies, materials or equipment purchased from a vendor known as a national or regional bidding cooperative at a price established under a competitive bidding process undertaken by the bidding cooperative.

**REPEALER CLAUSE** Any ordinance or parts thereof in conflict with this section are hereby repealed.

**SEVERABILITY CLAUSE** If any of the provisions of this ordinance are determined to be unconstitutional or unlawful by any court of competent jurisdiction, the remainder shall be severable and unaffected.
