ORDINANCE NO. 266-17

ORDINANCE AMENDING CITY CODE TO ALLOW DAY CARE FACILITIES FOR ALL AGES

SECTION 1 AMENDMENTS

The following be deleted from Section 66-8 (definitions of the City Code):

~~Child care means the care of a child by someone other than a parent or legal guardian in or outside the child's own home for gain or otherwise, on a regular basis, for any part of a 24-hour day.~~

The following be added to Section 66-8 (definitions of the City Code):

Day Care Facility: A facility by the State Department of Human Services, public or private, which for gain or otherwise regularly provides one or more person, as defined by the State Human Services Licensing Act, Minn. Stat. ch. 245A, with care, training, supervision, habilitation, rehabilitation or developmental guidance on a regular basis, for periods of less than 24 hours per day, in a place other than the person's own home. Day care facilities include, but are not limited to: family day care homes, group family day care homes, day care centers, day nurseries, nursery schools, developmental achievement centers for children, day training and rehabilitation services for adults, day treatment programs, adult day care centers, and day services.

Additional modifications (additions are noted with underlining and deletions are noted with strike through):

Section 66-209 Conditional Uses R-1 section of City Code

(e) Licensed ~~child care center~~ day care facility located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

Section 66-241 Conditional Uses R-1A section of City Code

(g) Licensed ~~child care center~~ day care facility located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

Section 66-387 Conditional Uses AG-1 section of City Code

(h) Licensed ~~child care center~~ day care facility located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

Section 66-418 Conditional Uses AG-2 section of City Code

(h) Licensed ~~child care center~~ day care facility located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

Section 66-450 Conditional Uses RR section of City Code

(h) Licensed ~~child care center~~ day care facility located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

Section 66-506 Conditional Uses Central Business District of City Code be deleted

~~(e) Licensed childcare center located in the same building or parcel as a religious institution such as churches, chapels, temples, and synagogues, provided the regulations of the Human Services Licensing Act, Minn. Stats. ch. 245A, and the state building, fire and health regulations are satisfactorily met.~~

The following be added to Section 66-504 Permitted Uses Central Business District of City Code

(al) Day Care Facilities licensed by the State of Minnesota Human Services Licensing Act, Minn. Stats. ch. 245A, provided that the state building, fire and health regulations are satisfactorily met.

SECTION 2 EFFECTIVE DATE


This Ordinance shall take full effect and be in full force after its passage and publication according to law.


