

RESOLUTION 26- 07

A RESOLUTION AMENDING THE MASTER FEE SCHEDULE BY ADOPTING A COMMUNITY CENTER USE FEE FOR NORTH LOGAN CITY

WHEREAS, North Logan City has established a master fee schedule to list and regulate the charges for various services within the city; and

WHEREAS, North Logan City has constructed the Community Center building for the benefit of residents; and

WHEREAS, the City Council has determined there is a need to adopt a Community Center Use Fee.

NOW, THEREFORE, be it resolved by the City Council of North Logan, Utah, that the Master Fee Schedule shall be changed as follows (highlighted portion added).

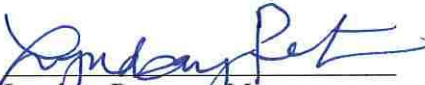
