

## RESOLUTION 17-14

### A RESOLUTION AMENDING THE MASTER FEE SCHEDULE FOR NORTH LOGAN CITY

WHEREAS, North Logan City has established a master fee schedule to list and regulate the charges for various services within the city; and

WHEREAS, the City Council has determined there is a need to modify and update the various fees from time to time.

NOW, THEREFORE, be it resolved by the City Council of North Logan, Utah, that the Master Fee Schedule shall be changed as follows (highlighted portion changed or added, strike-through deleted):

Wherever the Master Fee Schedule states "or actual cost to the city" the applicant must reimburse the city for all costs incurred by the city arising with respect to the fee including any reasonable and necessary legal, engineering, or other professional fees; costs of advertising or giving of legal notice; special material; or other direct costs.

These new fees shall be effective the 2nd day of November, 2017.


