ORDINANCE 31-93

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF QUEEN CREEK, ARIZONA AMENDING THE TOWN CODE BY ADDED CHAPTER 13 FLOOD CONTROL ARTICLE 13-1 DAMAGE AND EROSION PROVISIONS SECTIONS 13-1-1 DESIGNATION OF AUTHORITY AND SECTION 13-1-2 TECHNICAL DESIGN SPECIFICATIONS.

BE ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF QUEEN CREEK, ARIZONA AS FOLLOWS:

Section 1. That the Town Code of the Town of Queen Creek is hereby amended to add Chapter 13 Flood Control consisting of Article 13-1 Damage and Erosion Provisions consisting of Sections 13-1-1 Designation of Authority and Section 13-1-2 Technical Design Specifications reading as follows:

SECTION 13-1-1 DESIGNATION OF AUTHORITY

The Town of Queen Creek designates the Maricopa County Flood Control District as the enforcement authority for all flood plain management activities within the areas of special flood hazard as designated by the Federal Emergency Management Agency, Flood Insurance Rate Maps and for those areas identified by the Maricopa County Flood Control District to be areas of special flood concern within the Corporate Limits of the Town. For all other lands not within an area of special flood hazard as designated by the Federal Emergency Management Agency, Flood Insurance Rate Maps or designated to be areas of special flood concern by the Maricopa County Flood Control District, the authority for enforcement of drainage and erosion provisions shall be the Town of Queen Creek or other designated agent.
