

ORDINANCE NO. 635

AN ORDINANCE AMENDING SECTION I OF ORDINANCE No. 625 OF THE CITY OF REXBURG, IDAHO, WHICH PROVIDES FOR MONTHLY CHARGES FOR GARBAGE REMOVAL SERVICE FOR EACH OCCUPIED RESIDENCE AND/OR OCCUPIED RESIDENTIAL PREMISES WITHIN THE CITY OF REXBURG, IDAHO, BY INCREASING THE MONTHLY CHARGES AND PROVIDING WHEN THE INCREASED CHARGES SHALL BECOME EFFECTIVE, AND PROVIDING THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I. That Section I of Ordinance No. 625 of the City of Rexburg, Idaho, which provides for monthly charges for garbage removal service for each occupied residence and/or occupied residential premises within the City of Rexburg, Idaho, be, and the same is hereby amended to read as follows:

"FEES: From and after October 1, 1981, there is hereby assessed for each occupied residence and/or occupied residential premises within the City of Rexburg upon which refuse accumulates, the following monthly charges, to-wit:


Single family dwelling units, including
housetrailer and/or mobile homes
(whether within or without trailer
court), duplex units, triplex units,
apartment house units, and rooming
house units-----

-----\$4.50 plus \$3.00 for
each additional unit

All other residential units-----\$4.50


SECTION II. This ordinance shall take effect and be in force upon its passage and publication as provided by law.
