

ORDINANCE NO. 640

AN ORDINANCE AMENDING THAT PART OF SECTION I OF ORDINANCE NO. 599 OF THE CITY OF REXBURG, IDAHO, WHICH PROVIDES FOR MONTHLY CHARGES FOR GARBAGE REMOVAL SERVICE FOR NON-RESIDENTIAL PREMISES WITHIN THE CITY OF REXBURG, IDAHO, BY INCREASING THE MONTHLY CHARGES AND PROVIDING WHEN THE INCREASED CHARGES SHALL BECOME EFFECTIVE, AND PROVIDING THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I. That part of Section I or Ordinance No. 599 of the City of Rexburg, Idaho, which provides for monthly charges for garbage removal service for non-residential premises within the City of Rexburg, Idaho, upon which refuse accumulates, be, and the same is hereby amended to read as follows:

"FEES: From and after October 1, 1981, there is hereby assessed for garbage removal service for non-residential premises within the City of Rexburg, Idaho, upon which refuse accumulates, the following monthly charges, to-wit:

Bulk refuse pickup ---- \$16.50 per hour.

Minimum charge for all business, apartments, and/or trailer courts and churches is \$9.00.

All garbage and/or refuse requiring more than six cans shall be placed in cubic yard containers. Any garbage exceeding six cans will not be picked up."

SECTION II. This ordinance shall take effect and be in force upon its passage and publication as provided by law.
