

ORDINANCE NO. 650

AN ORDINANCE AMENDING SECTION I OF ORDINANCE NO. 635 OF THE CITY OF REXBURG, IDAHO, WHICH PROVIDES FOR MONTHLY CHARGES FOR GARBAGE REMOVAL SERVICE FOR EACH OCCUPIED RESIDENCE AND/OR OCCUPIED RESIDENTIAL PREMISES WITHIN THE CITY OF REXBURG, IDAHO, AND AMENDING SECTION I OF ORDINANCE NO. 640 OF THE CITY OF REXBURG, IDAHO, WHICH PROVIDES FOR MONTHLY CHARGES FOR GARBAGE REMOVAL SERVICE FOR NON-RESIDENTIAL PREMISES WITHIN THE CITY OF REXBURG, IDAHO, BY INCREASING THE MONTHLY CHARGES FOR GARBAGE REMOVAL FOR RESIDENTIAL PREMISES AND NON-RESIDENTIAL PREMISES, AND PROVIDING WHEN THE INCREASED CHARGES SHALL BECOME EFFECTIVE AND PROVIDING THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That part of Section I of Ordinance No. 635 which provides for monthly charges for garbage removal service for residential premises within the City of Rexburg, Idaho, upon which refuse accumulates be, and the same is hereby amended to read as follows:

"FEES: From and after October 1, 1982, there is hereby assessed for each occupied residence and/or occupied residential premises within the City of Rexburg upon which refuse accumulates, the following monthly charges, to-wit:

- Single family dwelling units, including  
housetrailer and/or mobile homes  
(whether within or without trailer  
court), duplex units, triplex units,  
apartment house units, and rooming  
house units-----\$5.50 plus \$3.00  
for each addition-  
al unit.
- All other residential units-----\$5.50

SECTION II: That part of Section I of Ordinance NO. 640 of the City of Rexburg, Idaho, which provides for monthly charges for garbage removal service for non-residential premises within the City of Rexburg, Idaho, upon which refuse accumulates, be, and the same is hereby amended to read as follows:

FEES: From and after October 1, 1982, there is hereby assessed for garbage removal service for non-residential premises within the City of Rexburg, Idaho, upon which refuse accumulates, the following monthly charges, to-wit:

Bulk refuse pickup ----- \$16.50 per hour.

Minimum charge for all businesses, apartments, and/or trailer courts and churches is \$11.00.

All garbage and/or refuse requiring more than six cans shall be placed in cubic yard containers. Any garbage exceeding six cans will not be picked up."

SECTION II. This ordinance shall take effect and be inforce upon its passage and publication as provided by law.
