

ORDINANCE NO. 652

AN ORDINANCE REPEALING SECTIONS II AND III OF ORDINANCE 527 OF THE CITY OF REXBURG, IDAHO, AND ADOPTING THE UNIFORM BUILDING CODE, 1982 EDITION, TOGETHER WITH AMENDMENT AND REVISION THEREOF WITH THE INCLUSION OF APPENDICES; PROVIDING THAT FROM AND AFTER MAY 24, 1983, APPLICANTS FOR CONSTRUCTION, REPAIR OF AND REMODELING OF ANY BUILDING SHALL PAY TO THE CITY CLERK FEES ESTABLISHED BY THE CITY COUNCIL; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Sections II and III of Ordinance No. 527 of the City of REXburg, Idaho, be, and the same are hereby repealed.

SECTION II: There is hereby adopted for the purpose of establishing rules and regulations for the construction, alteration, removal, demolition, equipment, use and occupancy, location and maintenance of buildings and structures, that certain Building Code known as the Uniform Building Code, copyrighted by the International Conference of Building Officials, 1982 Edition, together with amendment and revisions thereof with the inclusion of appendices. There has been on file, and there shall hereafter be kept on file, in the office of the Clerk three (3) copies of said Uniform Building Code, 1982 Edition, duly certified by the Clerk, for use and examination by the public.

SECTION III: From and after May 24, 1983, applicants for construction, repair of and remodelling of any building shall pay to the City Clerk fees established by the City Council.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall be in full force and effect from and after its passage, approval and due publication as provided by law.
