

ORDINANCE NO. 688

AN ORDINANCE REPEALING SECTION II OF ORDINANCE NO. 670 OF THE CITY OF REXBURG; ADOPTING THE UNIFORM BUILDING CODE, 1988 EDITION, TOGETHER WITH AMENDMENTS AND REVISIONS THEREOF WITH THE INCLUSION OF APPENDICES; REQUIRING COPIES OF SAID CODE TO BE KEPT IN THE OFFICE OF THE CITY CLERK; ALSO PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE AND FOR SEVERABILITY; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Section II of Ordinance No. 670 is hereby repealed.

SECTION II: There is hereby adopted for the purpose of establishing rules and regulations for the construction, alteration, removal, demolition, use and occupancy, location and maintenance of buildings and structures, that certain Building Code known as the Uniform Building Code, copyrighted by the International Conference of Building Officials, 1988 Edition, together with amendments and revisions thereof with the inclusion of appendices. There shall hereafter be kept on file, in the office of the Clerk three (3) copies of said Uniform Building Code, 1988 Edition, duly certified by the Clerk, for use and examination by the public.

SECTION III: Any person, firm or corporation violating any provision of this Ordinance shall, upon conviction thereof, be punishable by a fine not to exceed Three Hundred Dollars (\$300.00) or by imprisonment for not more than six (6) months or by both such fine and imprisonment for any single violation.

SECTION IV. All applicants for construction, repair of and remodeling of any building or the removal or demolition of any building shall pay to the City Clerk fees established by the City Council.


SECTION V: The sections of this Ordinance are

severable and the invalidity of a section shall not affect the validity of the remaining sections.


SECTION VI: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
