**ORDINANCE NO. 1102**

**AN ORDINANCE ESTABLISHING THE SALARIES OF THE MAYOR AND CITY COUNCIL MEMBERS OF THE CITY OF REXBURG, REPEALING ORDINANCES 941 AND 986; PROVIDING AN EFFECTIVE DATE TO COMMENCE; JANUARY 1, 2014.**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION 1. MAYOR'S SALARY.**

The salaries of the Mayor and City Council of the City of Rexburg shall be as follows:

**2.01.100** The Mayor shall receive an annual salary in the sum of Sixty Seven Thousand Five Hundred Ninety Two Dollars (\$67,592), and shall be paid Five Thousand Six Hundred Thirty Three dollars (\$5,633) monthly;

**SECTION 2. CITY COUNCIL SALARIES.**

The salaries of the members of the Rexburg City Council shall be as follows:

**2.02.160** Each member of the City Council shall receive an annual salary in the sum of Seventy Two Hundred dollars (\$7,200), and shall be paid Six Hundred Dollars (\$600.00) monthly.

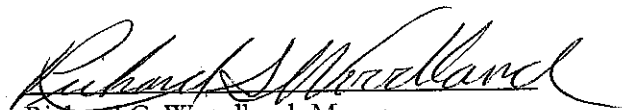
**SECTION 3. REPEAL OF CONFLICTING PROVISIONS.**

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed to the extent of such conflict.

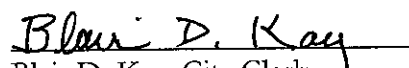
**SECTION 4. EFFECTIVE DATE.**

This ordinance shall be effective upon its passage and publication as provided by law. The salaries for the Mayor and City Council shall commence January 1, 2014, and shall be paid monthly.
