

ORDINANCE NO. 639

AN ORDINANCE DECLARING IT UNLAWFUL FOR ANY PERSON TO POSSESS ANY ALCOHOLIC LIQUOR OR BEER IN AN OPEN OR UNSEALED CONTAINER OF ANY KIND WHILE ON THE STREETS, PARKING LOTS OR SIDEWALKS OF THE CITY OF REXBURG, ALSO DECLARING IT UNLAWFUL FOR ANY PERSON TO WILFULLY AND CARELESSLY THROW CERTAIN OBJECTS INJURING ANY PERSON OR DESTROYING AND INJURING PROPERTY WITHIN THE CITY LIMITS OF REXBURG, IDAHO; ALSO DECLARING IT UNLAWFUL FOR ANY PERSON TO OBSTRUCT OR CAUSE TO BE OBSTRUCTED ANY CITY STREETS, SIDEWALKS OR PARKING LOTS IN THE CITY OF REXBURG, IDAHO, IN SUCH MANNER AS TO RENDER TRAVEL UPON THE PUBLIC STREETS, SIDEWALKS AND PARKING LOTS HAZARDOUS, DANGEROUS, OR ANNOYING TO PEDESTRIANS OR TRAVELERS; THAT VIOLATION OF SECTIONS I and II A AND B HEREOF SHALL CONSTITUTE A MISDEMEANOR; ALSO PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I. It shall be unlawful for any person to transport or have in his physical possession or control any alcoholic liquor or beer in an open or unsealed container of any kind while being upon the streets, parking lots or sidewalks of the City of Rexburg, Idaho.

SECTION II. A. It shall be unlawful for any person within the City limits of Rexburg, Idaho, to wilfully or carelessly throw any stone, stick, snowball, egg, bomb, missile, or other substance whereby any person is hit, or any window broken or any property injured or destroyed.

B. It shall be unlawful for a person within the City Limits of Rexburg, Idaho, to stand, obstruct, place or cause to be placed, any obstruction or to cause any object to be thrown or placed upon any street or sidewalk in such a manner as to render travel upon the public streets, sidewalks, parking lots or public places of Rexburg, Idaho, hazardous, dangerous, frightening or annoying to any pedestrian or traveler.

SECTION III. The violation of the foregoing Section I and Section II A and B shall constitute a misdemeanor.

SECTION IV. This ordinance shall take effect immediately upon its passage, approval and publication.

PEDESTRIANS OR TRAVELERS; THAT VIOLATION OF SECTIONS
I and II A AND B HEREOF SHALL CONSTITUTE A
MISDEMEANOR; ALSO PROVIDING WHEN THIS ORDINANCE SHALL
BECOME EFFECTIVE.
