

ORDINANCE NO. 714

AN ORDINANCE AMENDING ORDINANCE NO. 66 PROHIBITING THE POSSESSION, MAKING, MANUFACTURING, OR HAVING ACTUAL PHYSICAL CONTROL OVER AND DISCHARGING OF ANY FIRE CRACKERS, TORPEDOES, ICE BOMBS, OR ANY OTHER TYPE OF BOMB OR EXPLOSIVE WITHIN THE CORPORATE LIMITS OF THE CITY OF REXBURG, IDAHO.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

That Ordinance No. 66 be amended to read as follows:

SECTION I. It shall be unlawful for any person to discharge any fire cracker, firework not designated as a "safe and sane" firework, torpedo, firearm, air gun, pneumatic gun, spring gun, B-B gun, rocket, grenade, molotov cocktail, artillery projectile, pistol, catapult, flipper, ice bomb, pipe bomb, black powder bomb, or any other item(s), bomb(s) or explosive(s) capable of damaging property or injuring persons or animals within the corporate limits of the City of Rexburg, Idaho.

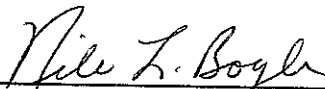
SECTION II. It shall be unlawful for any person to possess, make, manufacture, or have physical control over any firework not designated as a "safe and sane" firework, torpedo, grenade, molotov cocktail, artillery projectile, ice bomb, pipe bomb, black powder bomb, or any other type of bomb, explosive, components thereof, or similar item(s) capable of damaging property or injuring humans or animals within the corporate limits of the City of Rexburg, Idaho.

SECTION III. No person shall discharge any non-safe and sane firework anywhere in the city, except at a public exhibition pursuant to special written permit issued by the Rexburg City Fire Chief.

SECTION IV. Any person violating any provision of this ordinance shall be guilty of a misdemeanor, punishable by imprisonment in the county jail not exceeding six (6) months, or by a fine not exceeding three hundred dollars (\$300), or by both.

SECTION V. This ordinance shall be in full force and effect from and after its passage, approval and due publication as provided by law.
