PROVIDING FOR A COMPREHENSIVE MUNICIPAL CODE  
WHOSE SECTIONS MAY BE AMENDED, AND OR REPEALED  
UPON ACTIONS OF THE CITY COUNCIL; AND PROVIDING  
FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY  
OF REXBURG, IDAHO:

Section 1: It is hereby found and determined Codification Ordinance  
985 shall be and hereafter is the Municipal Code for the City of Rexburg. The  
Municipal Code is a living document whose sections may be added to, amended  
and/or repealed upon actions of the Rexburg City Council.

Section 2: The following is a compilation of significant city ordinances  
from 1883, when Rexburg was incorporated by the State of Idaho, to present.  
Please note amendments, additions, and/or deletions will be a constant; therefore,  
each subsequent version of the code will vary from its previous version based on  
additions and/or deletions to the code. This version of the code was approved by  
city council on **August 15<sup>th</sup>, 2007** to provide citizens and city officials the most  
efficient and complete access to the city's laws and ordinances to date.

Section 3: This version of the Rexburg Municipal Code reviews  
Ordinances 1 through 991.

Section 4: The code is organized into titles, chapters, and sections.  
There are also articles to help divide lengthy chapters into more searchable  
categories. Sections then, relate to chapters, and chapters relate to titles.

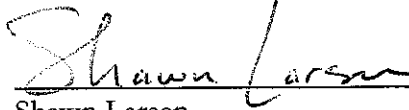

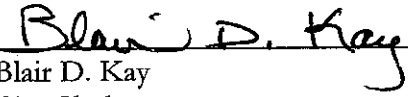

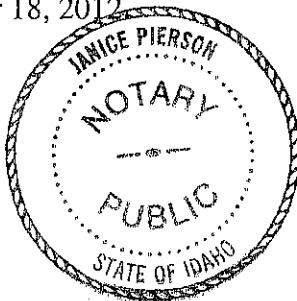
