

**RICHMOND CITY CORPORATION
ORDINANCE 2020-06**

WHEREAS, the City Council of Richmond has the responsibility for the general welfare of the City; and

WHEREAS, such responsibility includes but is not limited to, establishment of best management practices; and

WHEREAS, management practices may evolve over the passage of time:

NOW THEREFORE, the City Council of Richmond City, County of Cache, State of Utah, hereby adopts, passes and publishes the following:

AN ORDINANCE AMENDING TITLE 5-000 "COURTS", CHAPTER 5-100 "CITY COURT AND JUDGE", PART 5-101 "CREATED", PART 5-117 "FEES OF JUDGE PRO TEMPORE" AND TITLE 12-000 "LAND USE, DEVELOPMENT AND MANAGEMENT (LUDMO), PART 12-505 "NOTIFICATION AND PUBLIC HEARINGS".

BE IT ORDAINED BY THE CITY COUNCIL OF RICHMOND CITY, CACHE COUNTY, UTAH AS FOLLOWS:

1. Sections shall be amended such that the **highlighted** areas below shall be added and the ~~strikeout~~ areas shall be deleted.

Part 5-101 Created

There is hereby created and establish a city court, to be known as the ~~city court~~ of _____, **Richmond City Justice Court** and the office of Judge thereof. See U.C.A. § 78-4-1 for name of city court.

Part 5-117 Fees of Judge Pro Tempore

The fees of a Judge pro tempore in the city court, unless otherwise agreed by the party to the litigation and the person acting as Judge pro tempore, shall be ~~\$10 per day, to be taxed as cost by the prevailing party~~ **determined on a case by case basis as a Judge Pro Tempore is required.**

Part 12-505 Notification and Public Hearings

2. Public notice will be:
 - a. Posted in at least three public locations within the Richmond City limits.
 - ~~b. Posted on the Utah Public Notice Website.~~
 - e. **b.** Posted in a local newspaper that has access by the general public.
 - ~~d.~~ **c.** On the Richmond City Website.

~~e. In certain instances developed below notification in writing must be provided to certain residents, property owners, and/or entities.~~


~~(1) In the event of written notification being sent through the United States Postal System or other commercial mail deliverer, the notification must be turned over to the delivering source no less than ten (10) days before the event/action.~~

2. Should any section, clause, or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, in whole or in part, the same shall not affect the validity of the Ordinance as whole, or any other part thereof.
3. All ordinances, and the chapter, clauses, sections, or parts thereof in conflict with provisions of this ordinance are hereby repealed, but only insofar as is specifically provided for herein.
4. This ordinance shall become effective after the required public hearing and upon its posting as required by law.


THIS ORDINANCE shall be attached as an amendment to the Richmond City Municipal Code above referred to.
