ORDINANCE NO. 2017-03

AN ORDINANCE SUMMARY AMENDING SECTION 16-310 (a). - LAND PRESERVATION COMMISSION—ESTABLISHED, MEMBERSHIP OF THE SCIO TOWNSHIP CODE OF ORDINANCES AS STATED.

The Board of Trustees of the Township of Scio hereby ordains:

SECTION 1. CHANGES TO TOWNSHIP CODE.

The following amendments to Section 6-310 (a). - Land preservation commission—Established, Membership of the Township's Code of Ordinances, are hereby adopted:

- (a) The land preservation commission (LPC) shall consist of seven members nominated and approved by the township board. In making appointments of members to LPC, the township board shall appoint at least one person who has expertise or affiliation as follows:
- (1) One member who is a botanist or zoologist.
 - (2) One member of the township board of trustees.
 - (3) The remaining members shall be from the public-at-large. It will be desirable that at least one of these at-large members is an agricultural landowner or operates an agricultural business.

SECTION 2. INCONSISTENCIES REPEALED.

Any and all other ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.

SECTION 3. SEVERABILITY.

Should any section, clause or paragraph of this Ordinance be declared by court of competent jurisdiction to be invalid, the same will not affect the validity of the ordinance as a whole or part hereof other than the part declared to be invalid.

SECTION 4. SAVING CLAUSE.

That nothing in this Ordinance shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

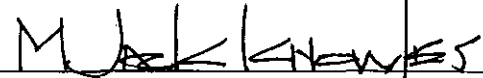
SECTION 5. AVAILABILITY.

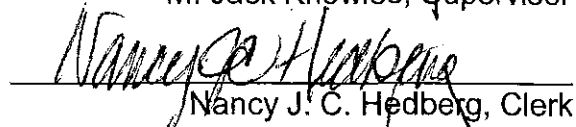
SECTION 6. EFFECTIVE DATE.

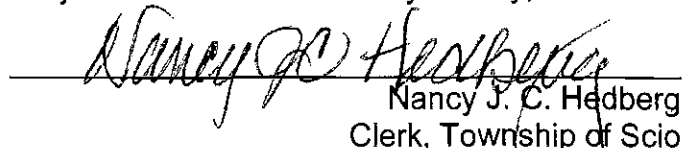
