ORDINANCE #2018-23

AN ORDINANCE AMENDING THE VILLAGE CODE, CHAPTER 340, "VEHICLES AND TRAFFIC", BY AMENDING SECTION 340-18 "THROUGH STREETS" AND SECTION 340-20 "FOUR-WAY STOP INTERSECTIONS", ESTABLISHING A FOUR WAY STOP AT LENOX AVENUE AND SOUTH RIDGEWOOD ROAD, AND AMENDING 340-12 "STOPPING, STANDING OR PARKING".

BE IT ORDAINED, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

Section 1.

Chapter 340 is hereby amended by the addition of the below streets to section 340-18 as follows:

Name of Street

Location

Glenview Road West Side

From Brentwood Drive to Hoskier Road

Ridgewood Road South

From the Maplewood line to Lenox Avenue

Ridgewood Road South

From Lenox Avenue to Walton Avenue

Section 2.

Chapter 340 is hereby amended by the addition of the below intersection to section 340-20 as follows:

Stop Sign On

Lenox Avenue
and South Ridgewood Road

Lenox Avenue and South Ridgewood Road

Section 3.

Chapter 340 is hereby amended by the addition of the below intersection to section 340-12 as follows:

Third Street	North	All	From Ridgewood Road South to Church Street
Tillou Road	North	All	From Ridgewood Road North north for 458 feet
Tillou Road	South	All	From Ridgewood Road North north for 485 feet

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 5

This ordinance shall take effect after final passage and publication as required by law.

Section 6

On passage this ordinance shall be codified.

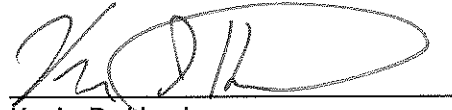
