ORDINANCE #2018-24

AN ORDINANCE AMENDING THE VILLAGE CODE, CHAPTER 143, "FEES", BY THE ADDITION OF APPLICATION FEES FOR CERTIFICATES OF USE AND TO AMEND AND RESTATE SECTION 143-39 TO INCLUDE POLICE DEPARTMENT FEES.

BE IT ORDAINED, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

Section 1.

Section 143-19 is hereby amended by the addition of **Fees for Applications for Certificates of Use** as follows:

Description	Code Section	Fee
Application fees for Certificate of Use:		
For premises to be owner occupied.	§237-12B	\$200
For rental premises to be occupied by persons related by blood, marriage, adoption or civil union.	§237-12B	\$200
For rental premises to be occupied by 3 or fewer persons.	§237-12B	\$200
For rental premises to be occupied by 4 or more persons.	§237-12B	\$100 per occupant
