

TOWNSHIP OF SOUTH ORANGE VILLAGE

RESOLUTION ESTABLISHING CALENDAR YEAR 2018 SEWER USER CHARGE

WHEREAS, Article IV of Chapter 130 of the Code of the Township of South Orange Village (Sections 130-49 to 130-55 inclusive) provides a system for the establishment of sewer user charges within the Village and for the payment of same by the owners of property from which the sewage of waster emanates; and

WHEREAS, the Code of the Township of South Orange Village provides that the Board of Trustees shall, by resolution, establish the amount of the user charges and the due date of the annual collection of said charges; and

WHEREAS, the Joint Meeting has, by resolution, determined that the total annual user charges to be borne by the citizens of South Orange during the year 2018 shall be \$1,187,822.04; and

WHEREAS, the Joint Meeting has, by proper resolution and in accord with the statutes of the United States and the State of New Jersey, determined as follows: that \$1,187,822.04 is the 2018 sewer user charge required from the Village to cover the Village's share for both the contract cost and annual sewer charge; and

WHEREAS, the Board of Trustees has determined to collect the aforesaid total \$1,187,822.04 from the citizens of South Orange through the impositions of uniform charges per dwelling unit as set forth in Article IV of Chapter 130 of the Code of the Township of South Orange Village; now, therefore

BE IT RESOLVED, by the board of Trustees of the Township of South Orange Village that the annual sewer user charge per dwelling unit for the year 2018 is hereby established to be \$290.00; and

BE IT FURTHER RESOLVED, that the total charge to be due from each owner of property within the Village shall be the basic rate set forth above multiplied, by number of dwelling units assessed to each owner in accord with section 130-51B of the Township of South Orange Village; and

BE IT FURTHER RESOLVED that said user charge shall be due and payable on March 12, 2018. The Village does hereby establish and allow a thirty (30) day grace period for the payment of said charge. If not paid by the end of the thirty-day grace period, said charge shall be deemed delinquent and bear interest from March 12, 2018 at the same rate and manner as delinquent real estate taxes. These charges shall be a lien upon the premises of the owner until paid and the Village shall have the same remedies for collection of thereof with interests, costs and penalties, as it has, for the collection of taxes upon real estate; and

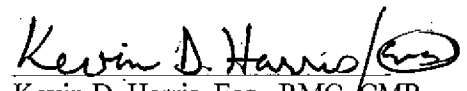
BE IT FURTHER RESOLVED that a copy of this resolution shall be delivered without charge to any owner of real estate within the Village who requests same.
