ORDINANCE #2021 - 01

**AN ORDINANCE AMENDING AND RESTATING THE COST OF
WATER AS SET FORTH IN CHAPTER 351, SECTION 15 OF THE
CODE OF THE TOWNSHIP OF SOUTH ORANGE VILLAGE**

WHEREAS, the Township of South Orange Village (the "Village") Water Utility finds, and the South Orange Village Water Committee concurs, that there is a need to amend and restate metered water rates as set forth in Chapter 351, Section 15 of the Code of the Township of South Orange Village (the "Code").

NOW THEREFORE, be it ordained, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, the following sections of the Code be amended and restated as follows:

SECTION I:

**351-15 Bills For Metered Service; Miscellaneous Water Charges; Service
Discontinuance For Nonpayment**

A. Metered rates.

1. Metered rates for water sold to Customers by the Township of South Orange Village shall be \$7.00 per 100 cubic feet (ccf).
2. In any case, where the metered volume is equal to or less than that noted by meter size in the following table during the time period noted, the minimum charge shall be the volume indicated below at the current rate.

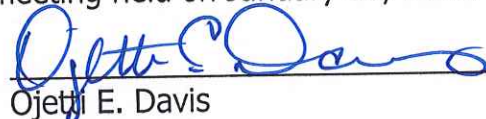
This ordinance amends the Code of the Township of South Orange Village, to revise Section 351-15 so as to increase the cost of water for certain meter and connection sizes.

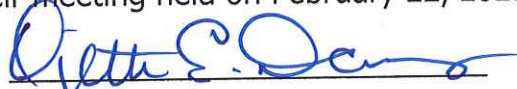
