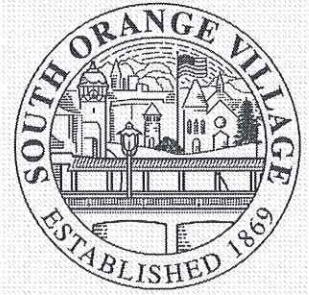

ORDINANCE #2021-04

Introduction: FEBRUARY 8, 2021

Adoption: MARCH 8, 2021

AN ORDINANCE AMENDING THE VILLAGE CODE, CHAPTER 340, 'TRAFFIC', BY AMENDING AND RESTATING SECTION 340-4, "SNOW EMERGENCY NO-PARKING AREAS", BY INCLUDING ALL MUNICIPAL PUBLIC ROADS AND DELETING SUBSECTION 340-4C

BE IT ORDAINED, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

Section 1.

As set forth below, Section 340-4, "Snow Emergency No-Parking Areas" is hereby amended and restated by the addition of all municipal public roads and the deletion of Subsection 340-4C, in its entirety.

Section 2.

Section 340-4 Snow Emergency No-Parking Areas

- A. Whenever snow has fallen and the accumulation is such that it covers the street or highway and the Coordinator of the Office of Emergency Management has found that a prohibition is necessary and has formally announced same, no vehicle shall be parked on either side of any roadway within the Township of South Orange Village including, but not limited to, the following streets or parts thereof:

Name of Street	Location
Irvington Avenue	Entire length
Scotland Road	Entire length
South Orange Avenue	Entire length
Valley Street	Entire length
Wyoming Avenue, North and South	Entire length



All Municipal Public Roads Within the Township of South Orange Village	Entire length

- B. The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

Section 3.

Repealer

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 4.

This ordinance shall take effect after final passage and publication as required by law.

Section 5.

On passage this ordinance shall be codified.
