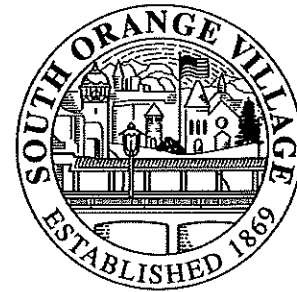

ORDINANCE #2022-35

Adoption: December 27, 2022

AN ORDINANCE AMENDING AND RESTATING THE VILLAGE CODE, CHAPTER 143, "FEES," BY AMENDING MEMBERSHIP AND VARIOUS FEES RELATING TO RECREATION PROGRAMS

BE IT ORDAINED, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1.

The Code of the Township of South Orange Village, Section 143 –17, Fees, Parks and Recreation, is hereby restated and amended in its entirety as follows:

<u>Membership Discounts:</u>		
All in membership will provide \$5 discount on select indoor programming.		
<u>Refund Policy:</u>		
Once a program begins, pro-rated refunds or credits will only be issued for medical reasons or relocation with documentation.		
Prior to the beginning of a program, refund or credit will be issued less a \$10 administrative fee unless otherwise specified in program information.		
Director has discretion for refunds based on a case by case basis.		
<u>Pro-rating Policy:</u>		
Pro-rating of some fees is permitted based on program circumstances and current enrollment with the approval of the Director.		
<u>Payment Plans:</u>		
Payment plans for program registration is permitted with the approval of the Director or Office Manager.		
<u>Multi-program and Early Bird Registration Discounts:</u>		
Multi-program and early registration discounts may apply to some programs if specified in program registration information.		
<u>Sample Classes:</u>		
Free sample classes may be permitted, depending upon circumstances and enrollment, with the approval of the Director.		

SECTION 2. This ordinance shall take effect upon final passage and publication as required by law

SECTION 3. On passage this ordinance shall be codified.
