## **ORDINANCE #2025-05**

**Introduction: February 24, 2025**

**Adoption: March 24, 2025**

### **AN ORDINANCE OF SOUTH ORANGE VILLAGE AMENDING AND RESTATING VILLAGE CODE CHAPTER 157 FIRE PREVENTION, SECTION 7 – TECHNICAL AMENDMENTS**

**BE IT ORDAINED**, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

**SECTION 1.** Section G of Village Code Chapter 157-7 Pyrotechnic devises prohibited shall be amended and restated in its entirety as follows:

#### **G. Pyrotechnic devises prohibited**

1. It shall be unlawful for any person to ignite, display, possess or use in any manner whatsoever, within any commercial structure, any pyrotechnics, sparklers and smoke/fog machines except upon review and written permission of the Fire Official, based upon application to the Fire Official, 30 days in advance of such ignition, display, possession or use which permission may be granted in the Fire Official's sole discretion and in accordance with such conditions and costs, if any, as may be imposed by the Fire Official.
2. Exempted from the provisions of this section is any testing or training exercises conducted by the Village Fire Bureau, Fire Department or other recognized fire brigade

#### **SECTION 2.**

All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

#### **SECTION 3.**

This ordinance shall take effect upon final passage and publication as required by law.

#### **SECTION 4.**

On passage this ordinance shall be codified.
