## **ORDINANCE #2025-13**

**Introduction: May 27, 2025**

**Adoption: June 23, 2025**

### **AN ORDINANCE TO AMEND THE CODE OF SOUTH ORANGE VILLAGE, SECTIONS 340-10 AND 340-13 REGULATING PARKING**

**BE IT ORDAINED**, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

#### **SECTION 1.**

The Code of South Orange Village, Section 340-10 – Parking Prohibited At All Times, is hereby amended to correct the misspelling of "Monstrose" as follows:

| <b>Name of Street</b> | <b>Side</b> | <b>Location</b>                      |
|-----------------------|-------------|--------------------------------------|
| Montrose Avenue       | North       | From Centre Street west for 311 feet |

#### **SECTION 2.**

The Code of South Orange Village, Section 340-10 – Parking Prohibited At All Times, is hereby amended by the deletion of the following:

| <b>Name of Street</b> | <b>Side</b> | <b>Location</b>                      |
|-----------------------|-------------|--------------------------------------|
| Montrose Avenue       | North       | From Vose Avenue to East Clark Place |
| Montrose Avenue       | South       | From Vose Avenue to Meeker Street    |

#### **SECTION 3.**

The Code of South Orange Village, Section 340-10 – Parking Prohibited At All Times, is hereby amended by the addition of the following:

| <b>Name of Street</b> | <b>Side</b> | <b>Location</b>                          |
|-----------------------|-------------|------------------------------------------|
| West Montrose Avenue  | North       | From Vose Avenue to North Ridgewood Road |

The Code of South Orange Village, Section 340-13 – Parking Time Limited, is hereby amended by the deletion of the following:

|-----------------------|-------------|--------------------------------------------------------------------|----------------------------------------------|
| Montrose Avenue       | North       | 2 hrs; 8:00 a.m. to 6:00 p.m./except Saturday, Sunday and holidays | From Ridgewood Road East to East Clark Place |
| Montrose Avenue       | South       | 2 hrs; 8:00 a.m. to 6:00 p.m./except Saturday, Sunday and holidays | From Ridgewood Road East to Meeker Street    |

#### **SECTION 5.**

This ordinance shall take effect upon final passage and publication as required by law.

#### **SECTION 6.**

On passage this ordinance shall be codified.
