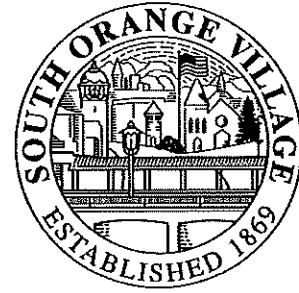

ORDINANCE #2025-21

Introduction: September 8, 2025

Adoption: October 13, 2025

AN ORDINANCE AUTHORIZING HANDICAPPED PARKING FOR GIOVANNA ROSE NIRO RESIDING AT 183 TICHENOR AVENUE, SOUTH ORANGE, AND THE AMENDMENT OF CODE CHAPTER 340-38, SUBSECTION B.

WHEREAS, pursuant to NJSA 39:4-197.6 and South Orange Village Code Chapter 340-38, handicapped parking may be authorized on public roadways; and

WHEREAS, Giovanna Rose Niro has been designated handicapped by the New Jersey Motor Vehicle Commission, and resides at 183 Tichenor Avenue; and

WHEREAS, Giovanna Rose Niro resides on the West side of Tichenor Avenue, on which side parking is not permitted; and

WHEREAS, on the East side of Tichenor Avenue parking is permitted and previously Chapter 340-38, Subsection B had been amended to permit handicapped parking at 190 Tichenor Avenue by an individual with a disability dedication number P2837583; and

WHEREAS, the individual formerly using the handicapped parking space at 190 Tichenor Avenue no longer does so.

NOW, THEREFORE, BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1.

The single car parking space, formerly authorized for Permit P2837583 in front of 190 Tichenor Avenue, is hereby designated as the handicapped parking space for Giovanna Rose Niro having been issued Permit P2937330.



SECTION 2.

South Orange Code Chapter 340-38, Subsection B is hereby amended to replace Permit P2837583 to Permit P2937330 as follows:

Tichenor Avenue	In front of No. 190, for Permit P2937330

This ordinance shall take effect upon final passage and publication as required by law.

SECTION 4.

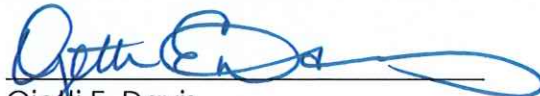
On passage this ordinance shall not be codified, other than the amendment of Code Chapter 340-38, Subsection B.

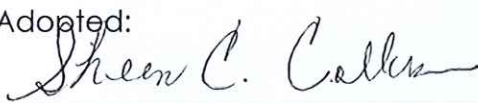
