AN ORDINANCE OF SOUTH ORANGE VILLAGE AMENDING AND RESTATING VILLAGE CODE CHAPTER 143 FEES, SECTION 39 – OTHER FEES AS IT REGARDS POLICE SIDE JOBS

BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1. Village Code Chapter 143-39 Other Fees shall be amended and restated in its entirety as follows:
