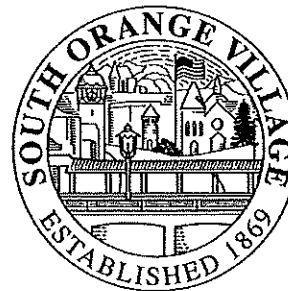

ORDINANCE #2025-25

Introduction: November 24, 2025

Adoption: December 22, 2025

AN ORDINANCE OF SOUTH ORANGE VILLAGE AMENDING AND RESTATING VILLAGE CODE CHAPTER 291 SOLID WASTE DISPOSAL, SECTION 2(B) – USE OF FACILITY AND AMENDING AND RESTATING CHAPTER 143 FEES, SECTION 26 – SOLID WASTE DISPOSAL

WHEREAS, there exists a need to conform the Village Code insofar as items detailed in Village Code Section 291-2(B) do not reflect the varied nature of items accepted by the Public Works Recycling Center; and

WHEREAS, there exists a need to increase fees associated with Solid Waste Disposal.

NOW THEREFORE BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1. Village Code Chapter 291-2 Use of Facility shall be amended and restated in its entirety as follows:

291-2 Use Of Facility

- A. The solid waste facility operated by the discretion of South Orange Village on an as-needed basis within the confines of South Orange Village may be used solely by the residents of South Orange for the depositing of the types of solid waste described in Subsection B of this section, provided that it comes from their homes and is transported to the solid waste facility in their private passenger vehicles, vans or pickup noncommercial vehicles.
- B. The solid waste facility referred to in Subsection A above will only receive scrap metal, freon (CFC) containing items, brush (excluding grass clippings but which shall include garden debris hedge clippings, yard rakings, leaves and brush branches of trees not exceeding four feet in length), high grade and mixed paper, clothing (not textiles), used motor oil, and routine curbside recycling (including cardboard, plastic containers, glass bottles, steel/tin and aluminum cans). The facility will not receive other solid waste or automobile parts.

SECTION 2.

Village Code Chapter 143 - Fees, Section 26 – Solid Waste Disposal is amended and restated as follows:

143-26 Solid Waste Disposal



Description	Code Section	Fee

Delivery of Mulch/Humus	§ <u>291-7</u>	\$65

SECTION 3.

All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

SECTION 4.

This ordinance shall take effect upon final passage and publication as required by law.

SECTION 5.

On passage this ordinance shall be codified.
