AN ORDINANCE RESCINDING HANDICAPPED PARKING FOR NANDI BARNHARDT AT 65 RANDOLPH PLACE, SOUTH ORANGE, AND THE AMENDMENT OF CODE CHAPTER 340-38, SUBSECTION B.

WHEREAS, pursuant to NJSA 39:4-197.6 and South Orange Village Code Chapter 340-38, Ordinance #2024-23 was adopted to provide handicapped parking for Nandi Barnhardt at 65 Randolph Place; and

WHEREAS, Nandi Barnhardt has now advised that she now longer resides at 65 Randolph Place and does not need the handicapped parking rights provided for in Ordinance #2024-23.

NOW, THEREFORE, BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1.

A single car parking space, directly in front of 65 Randolph Place, is hereby rescinded as a handicapped parking space, specifically for Nandi Barnhardt.

SECTION 2.

South Orange Code Chapter 340-38, Subsection B is hereby amended by removing the following:

Randolph Place	In front of No. 65, for Permit P2913280

This ordinance shall take effect upon final passage and publication as required by law.

SECTION 4.

On passage this ordinance shall not be codified, other than the Section 2 removal from Code Chapter 340-38, Subsection B.
