ORDINANCE No. 03-2023

AN ORDINANCE AMENDING SECTION 15.3.08.010 OF THE SPANISH FORK MUNICIPAL CODE PERTAINING TO THE ORGANIZATION OF THE DEVELOPMENT REVIEW COMMITTEE

WHEREAS Section 15.3.08.010 of the Spanish Fork Municipal Code provides regulation concerning the organization of the Development Review Committee;

WHEREAS Spanish Fork City has organized a Police Department and a Fire & EMS Department, which formerly were combined in a single Public Safety Department;

WHEREAS the City Council desires to amend Section 15.3.08.010 of the Spanish Fork Municipal Code to remove references to the Public Safety Director, changing it to the Fire Marshal;

WHEREAS a public hearing was held before the Planning Commission on March 1, 2023, whereat public comment was received; and

WHEREAS a public hearing was held before the Spanish Fork City Council on March 7, 2023, whereat additional public comment was received;

NOW THEREFORE, be it enacted and ordained by the Spanish Fork City Council as follows:

Section 1. Amend Section 15.3.08.010 of the Spanish Fork Municipal Code.

Section 15.3.08.010 of the Spanish Fork Municipal Code, pertaining to the organization of the Development Review Committee, is hereby amended as follows:

15.3.08.010 Administrative Bodies And Officers

...

B. Development Review Committee:


1. Organization: The DRC shall consist of the City Public Works Director, Engineering Division Manager, Electric Division Superintendent, City Manager, City Community Development Director, City Attorney, ~~Public Safety Director~~ Fire Marshal, Parks and Recreation Director and Building Official. An alternate member may be designated by each member, who has the authority to attend and vote in the ~~place~~-absence of the member. Other entities may be invited to participate as non-voting members, such as utility companies, irrigation companies, the US Postal Service or others. The City Public Works Director shall be the chair of the DRC and shall retain the right to cast a vote while acting as chair. A quorum of the Committee necessary before any business can be transacted shall consist of five (5) voting members. A majority vote of a quorum shall be necessary to approve any item or recommend approval of any item to the Commission or Council.


