AN ORDINANCE AMENDING CHAPTER 3 [SUPPLEMENTARY REQUIREMENTS AND PROCEDURES APPLICABLE WITHIN ZONES] TO ADD A NEW SECTION 3-3 5 ENTITLED "RENDERING PLANTS PROHIBITED"

THE BOARD OF COUNTY COMMISSIONERS FO THE COUNTY OF UTAH ORDAINS AS FOLLOWS

PART I

Chapter 3 [Supplementary Requirements and Procedures Applicable Within Zones] is hereby amended to add a new section 3-3 5, which shall read as follows

3-3 5 RENDERING PLANTS

Provisions of the zoning ordinance permitting the care and keeping of livestock, fowl, or furbearers, fabrication and portion control meat sorting, processing, packaging or storage recycling of useful materials, or other uses of land not specifically containing the words "rendering plant" shall not be deemed to permit the rendering, storage or processing of livestock or animal by products, or the storage or processing of animal waste materials

Exclusion this section shall not prevent the customary farm practice of removing manure from a barn or pen used for raising livestock, fowl, or furbearers and applying the manure as fertilizer on fields used for raising crops or pasture

PART III

This ordinance shall take effect 1 sixteen (16) days after it is passed, or 2 after it has been published whichever date is later

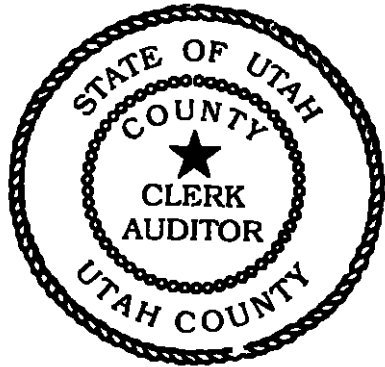

THE BOARD OF COUNTY COMMISSIONERS FOR THE COUNTY OF UTAH ORDAINS AS FOLLOWS

PART I

Chapter 3 [Supplementary Requirements and Procedures Applicable Within Zones] is hereby amended to add a new section 3-35 which shall read as follows

3-35 RENDERING PLANTS

Provisions of the zoning ordinance permitting the care and keeping of livestock, fowl or furbearers, fabrication and portion control meat sorting, processing, packaging or storage, recycling of useful materials or other uses of land not specifically containing the words "rendering plant" shall not be deemed to permit the rendering, storage or processing of livestock or animal by-products or the storage or processing of animal waste materials.

Exclusion: this section shall not prevent the customary farm practice of removing manure from a barn or pen used for raising livestock, fowl or furbearers and applying the manure as fertilizer on fields used for raising crops or pasture.
