AN ORDINANCE AMENDING THE UTAH COUNTY
ZONING ORDINANCE AS TO SECTIONS 7-11-A.

THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF UTAH ORDAINS AS
FOLLOWS:

PART I:

Section 7-11-A of the Utah County Zoning Ordinance is hereby amended to read as follows:

There is hereby created a Board of Adjustment which shall consists of five members (termed "regular members") appointed by the County Commission plus whatever number of alternate members the County Commission may appoint. The term of a regular member shall be for a period of three years and until their successors are appointed, and the term of an alternate member shall be for the time period specified at the time of appointment. The terms of the regular members shall be staggered so that the term of at least one member shall expire each year on December 31. Appointments to fill vacancies shall be for the unexpired term of the vacant office.

The appointment of each member of the Board of Adjustment as such exists at the time of the passage of this ordinance is hereby ratified and continued for the same term as existed under the prior appointment.

PART II:

Insert pages reflecting the above amendments are hereby ordered to be filed in the three (3) file copies of the Official Utah County Zoning Ordinance on file with the Utah County Clerk/Auditor.

PART III:

This ordinance shall take effect 1. sixteen (16) days after it is passed, or 2. after it has been published, whichever date is later.

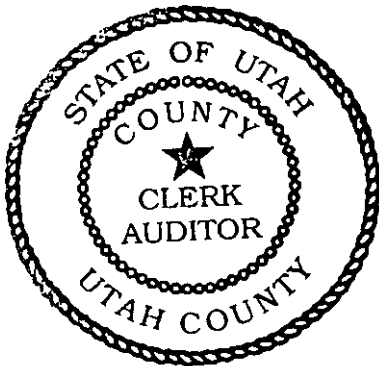
